Consolidated Entity (as/at March 31, 2020)

Site Stage Glossary:

1. **Phase I Environmental Site Assessment (ESA):** Review to determine potential contamination
2. **Phase II ESA:** Sampling to determine if contamination is present
3. **Phase III ESA:** Sampling to delineate the extent of contamination
4. **Remedial Action Plan (RAP):** A plan to remediate or clean up a contaminated site
5. **Remediation:** The act of remediating or cleaning up a site
6. **Monitoring:** Observing changes at a site over time
7. **Care and Maintenance:** Activities to ensure a site remains safe and in a stable condition
